Registration of paper title and Abstract (Abstract not exceeding 350 words) in English or BIH languages, written in Windows Word, font Times New Roman, size 12 pt, should be submitted to the organizer no later than February 15th 2012 on e-mail: *symposium@agrofabl.org*.

Registration form and instructions for abstract writing are available at *www.agrofabl.org*.

All abstracts are subject to the review by Scientific Committee; hence the review outcome will be submitted to the respective authors. The authors will receive acceptance note no later than February 25th 2012. Authors can select type of presentations in the Registration form (oral or poster); however the Organisers retain the right to decide on the number of oral presentation.

Platform presentation should be prepared in English and presented either in English or BiH languages. Posters should be prepared in English language, size 60 x 90 cm.

Authors will receive notice on this matter in time. All papers accepted by the Scientific Committee, should be personally presented by the author or co-author, orally or by poster, in order to be published in *Agro-knowledge Journal*.

Authors of the papers aiming to publish in *Agro-knowledge Journal* should submit full papers no later than the beginning of the Symposium. Papers should be written in accordance to the instructions for publishing in *Agro-knowledge Journal* in printed and electronic form. Papers written in BIH languages should include a summary in English, titles and headings of tables, charts and pictures in BIH languages and English.

Keynote Speakers will be invited by the Organizer. Other participants submit papers independently.

USEFUL INFORMATION

Trebinje is situated in the south of the Republic of Srpska, Bosnia and Herzegovina, with a good road connection to Sarajevo, Podgorica and Dubrovnik. Trebinje is located 45 km from the airport Dubrovnik (Croatia) and 70 km from the airport Tivat (Montenegro). For all the participants who arrive at one of these airports free transportation will be provided to Trebinje at the expense of the organizers. The participants are required to submit the exact time of the arrival at the airport by March 15th of 2012. In the event of unforeseen circumstances and untimely notice of arrival, the participants can take a taxi or use car rental services at the airport. Taxi fares from Dubrovnik to Trebinje is about $50 \in$, and from Tivat to Trebinje, about $60 \in$. Car rental services at the airport are about $70 \in$ per day plus travel expenses. There is no bus or train communication between these airports and Trebinje.
